INTERIM ORDER

1. The case was heard on 04/12/2025, as scheduled, in the court room of the Commission.
2. At the outset, Sh. Akshay Gupta Counsel for the petitioner re-iterated the contents of the petition and submitted that initially proposed bore was failed and request was submitted for shifting the site of connection alongwith bore failure certificate from hydrologist but the connection has not been released till date on a complaint made by third party.
3. The petitioner himself was present in the court and stated that requisite amount as per demand notice has already been deposited but the connection has not been released on a complaint made by third party. The material for release of connection i.e. poles etc is already lying at site.
4. To the query of the Commission, the counsel of the respondent submitted that there is no procedure/ instructions for shifting of bore site before release of tubewell connection, besides a complaint from neighbourer. The respondents further submitted that the connection will be released with in 15 days.
5. The Commission was apprised that UHBVN and DHBVN has filed a petition for defining a procedure for pre-release shifting of the tubewell connections due to various reasons like bore failure, acquisition of land by Govt. etc. which is listed for hearing on 06/01/2026.
6. The Commission after going through the contents of the complaint finds no weight in the same and as an interim measure directs the respondent to release the connection with in 15 days and compliance report be filed before next date of hearing. The case will be heard alongwith earlier petition no. 88 of 2025 filed by DISCOMs.
7. The matter to come up next on 06/01/2026.
