### **INTERIM ORDER**

1. The case was heard on 20/03/2024, as scheduled, in the court room of the Commission.
2. At the outset, the petitioner Sh. B. K. Aggarwal re-iterated his contentions regarding wrong billing, interest on ACD and calculation of fixed charges and submitted that the order dated 06/11/2022 of the CGRF has not been complied with, completely, till date. The petitioner also submitted written statement to the Commission.
3. The Commission enquired about the basic issues from the petitioner. The petitioner failed to pin point issues before the Commission and stated he has filed written statement.
4. Ms. Sonia Madan counsel of the respondent-DHBVN submitted that the petitioner is raising issues which are beyond the scope of present petition and CGRF's order dated 06/11/2022 & the order of CGRF stands already complied and an affidavit to this effect has already been submitted to the Commission on 12/12/2023.
5. After hearing the parties, the commission observes that the written statement submitted by the petitioner is required to be replied by the respondent-DHBVN. The Commission directed respondent-DHBVN to submit a pointwise reply to the written statement of the petitioner specifically to the points related to CGRF's order dated 06/11/2022 and directs SDO/ Op, Sohna Road, Gurugram to appear in person on the next date of hearing.
6. The matter to come up again on 12/04/2024.
