INTERIM ORDER

1. The case was taken up for public hearing on 07.01.2026 as scheduled, in the court room of the Commission.
2. In order to afford an opportunity to the general public / Stakeholders to file their objections / suggestions / comments, the petition filed by HPGCL was made available on the website of the Commission as well as that of the petitioner.
3. The Public Notice was issued by the petitioner in 'Amar Ujala' and 'The Tribune' dated 28.11.2025 for inviting objections from the stakeholders / General Public or any interested person, in accordance with the provisions of Section 64 of the Electricity Act, 2003 read with the Haryana Electricity Regulatory Commission (Conduct of Business) Regulations, 2019 as amended from time to time. Further, a Public Notice was also issued by the Commission, communicating the last date of filing objection as well as the date of hearing,

in the 'Dainik Bhaskar' and 'The Tribune' dated 17.12.2025 and was hosted on the Commission's website under the head 'schedule of hearing'.

4. In response to the public notice no comments/ objections were filed by any stakeholder.
5. Upon hearing the petitioner (HPGCL), the Commission is of the considered view that although public hearing is concluded, but in order to prudently conduct the exercise of tariff determination, the petitioner needs to file the information/documents sought vide letter no. HERC/Tariff/2496 dated 30.12.2025, as well as the followings, within one week from the date of issue of this order, with copy to HPPC: -

- a) Data of Contractual and regular employees for the FY 2024-25, as per the following format: -

Also provide break-up of employees cost, for the FY 2024-25, into contractual and regular employees.

- b) Analysis of performance of agency appointed for 3rd party sampling of coal. Also provide details of coal quality claims raised on coal companies, claims settled, claims rejected and claims outstanding, for last three years.
 - c) Data including plant-wise summary of energy (Mus) backed down by DISCOMs (HPPC), during last five years.
 - d) Generation from April, 2024 to December, 2025 along with the previous year for the corresponding period.
 - e) Reports of internal technical committees and action taken reports on the same, for last three years.
 - f) Unavailability of Hydro power plants, during the period of availability of water, during last three years.
 - g) Details of working capital loan along with applicable rate of interest thereon.
6. The public hearing is complete and the order is reserved.
