**INTERIM ORDER**

1. The case was heard on 07/01/2026, as scheduled, in the court room of the Commission.
2. Sh. Lovepreet Singh Counsel for the respondents submitted that the bidding process for hiring the consultant has been initiated.
3. The Commission noted with concern that the hiring of consultant was to be completed before 15/12/2025 whereas only bids have been invited till date.
4. The Commission called the SE/P&D present in the court to explain the reasons of delay but found the reasoning given by the SE is

unconvincing. The counsel for the respondents assured to make up the delay and finalise the DPR as per schedule i.e. by 31/03/2026.

5. The Commission finds lack of ownership of the project among the officers of UHBVN and decides to implead the Chief Engineer/PD&C as a party in the matter who is responsible for all the activities described in the agreed schedule.
6. The Commission directs the parties to remain present personally in the court on the next date of hearing and to submit monthly progress report of the project. Further, the concerned officers are directed to put in sincere efforts to complete the project in scheduled time.
7. The matter to come up next on 13/03/2026.
