INTERIM ORDER

(Admitting the Complaint/Petition and Fixing Date of Hearing)

1. The present complaint/petition has been filed by Zion Sector–78 Allottees Association against Dakshin Haryana Bijli Vitran Nigam Limited & Anr. alleging non-compliance of the order dated 13.10.2025 passed by the CGRF, Hissar in Case No. DH/CGRF/4944/2025, whereby the Respondents were directed to sanction and release the requisite electricity load to the Complainant within the stipulated statutory period in terms of Section 43 of the Electricity Act, 2003. It is the grievance of the Complainant that despite lapse of considerable time and readiness to deposit the requisite charges as determined by the Respondents, no permanent electricity connection has been sanctioned, resulting in continued financial burden and hardship to the residents. The Complainant has, therefore,

approached this Commission seeking initiation of proceedings under Sections 142, 146 and 149 of the Electricity Act, 2003 along with consequential reliefs. Accordingly, the complaint stands **admitted** for consideration.

2. **In view of the above, the matter is fixed for hearing on 06 /05 /2026 at 11:30 A.M.** before the Commission. The parties shall be duly informed and required notices, as per procedure, should be issued for their appearance.
3. The Respondent No. 2 is directed to **appear in person** on the date so fixed and **shall submit a compliance report** on the DH/CGRF/4944/2025 order dated 13.10.2025 before the date fixed for hearing with an advance copy served to the complaint/ petitioner.
4. The present order shall be uploaded on the official website of the Commission for the information of all concerned.
