INTERIM ORDER

(Admitting the Complaint/Petition and Fixing Date of Hearing)

1. The present complaint has been filed by Savana Welfare Association, Sector-88, Faridabad under Sections 142, 146 and 149 of the Electricity Act, 2003 alleging non-compliance by the respondents in granting slab benefit as per the Single Point Supply to Residential Colonies/Group Housing Societies Regulations dated 09.01.2013 and subsequent regulations issued in 2020. The complainant has submitted that despite providing the occupancy certificate and due intimation in the year 2020, the respondents granted slab benefit only from June 2023 instead of from the date of connection, and further failed to comply with the order dated 09.12.2025 passed by the Consumer Grievance Redressal

Forum (CGRF), thereby necessitating the filing of the present complaint. Accordingly, the complaint stands **admitted** for consideration.

2. **In view of the above, the matter is fixed for hearing on 22/04/2026 at 11:30 A.M.** before the Commission. The parties shall be duly informed and required notices, as per procedure, should be issued for their appearance.
3. The Respondent No. 2 is directed to **appear in person** on the date so fixed and **shall submit a compliance report** on the DH/CGRF/4965/2025 order dated 09.12.2025 before the date fixed for hearing with an advance copy served to the complaint/ petitioner.
4. The present order shall be uploaded on the official website of the Commission for the information of all concerned.
