ORDER

- 1. The Petition was filed by the Petitioner as the respondents have failed to comply with the order dated 24/02/2025 passed by Consumer Grievance Redressal Forum, Dakshin Haryana Bijli Vitran Nigam, Hisar, Haryana in case bearing DH/CGRF/4762/2024 praying to:
 - a) Initiate an inquiry against the respondents for violating the order

- dated 24/02/2025 passed by the CGRF, Hisar in DH/CGRF/4762/2024, also various regulation regarding refund of security deposit and payment of interest on ACD/Security ,etc, and take strict action against the guilty officers under section 142, 146 and 149 of Electricity Act, 2003 and;
- b) Direct the Respondents to allow slab benefit from the date of occupancy of the flats as per the list provided by the Petitioner, pay the penal interest on the ACD amount of Rs.12,00,000/- from the date of payment as per the clause 5.8.1 & 5.8.2 of Regulation No. 34/2016 i.e. the Haryana Electricity Regulatory Commission (Duty to supply electricity on request, Power to recover expenditure incurred in providing supply and Power to require security) Regulations, 2016 and Sales Instruction 9/2016 issued by the respondents and 4 % rebate for the admitted period for which no payment was made and:
- c) Award the compensation and costs of present proceedings including Rs.50,000/- paid as court fees, in favour of PETITIONER and against the Respondent and;
- d) Any other or further order which this Hon'ble Commission may deem fit and proper in the facts and circumstances of the case in favour of the PETITIONER in the interest of justice.
- 2. The case was heard on 06/08/2025, as scheduled, in the court room of the Commission. None appeared on behalf of petitioner.
- 3. The SDO concerned present in the court submitted that the compliance to the order of CGRF has been made.
- 4. The Commission was apprised that Sh. B.P.Agarwal Counsel for the petitioner vide email dated 05/08/2025 has intimated that the order dated 24/02/2025 has been complied with and nothing survived in the present complaint.
- 5. The Commission in cognizance to the intimation of compliance conveyed by the parties observes that nothing remains to be adjudicated in the present petition and the same is disposed of as infructuous.
