AFFIDAVIT ON BEHALF OF RESPONDENT NO. 16, HARYANA ELECTRICITY REGULATORY COMMISSION (“HERC”), IN PURSUANCE OF DIRECTIONS PASSED BY THE HON’BLE TRIBUNAL ON 29.08.2025 IN ORIGINAL PETITION NO. 1 OF 2025.

MAY IT PLEASE THIS HON’BLE COURT:

I, Jai Prakash, S/o Shri Mangat Ram, aged about 32 years working as Secretary of Haryana Electricity Regulatory Commission, Respondent No. 16 in the above matter, having address at Bays 33-34, Sector 4. Panchkula, do hereby swear and solemnly affirm and state as under:

1. Vide order dated 29.08.2025, the Hon'ble APTEL had directed the Respondent Commissions to file an affidavit with respect to the below mentioned information and also to upload a copy of the said affidavit on their respective websites for information of the general public/ distribution companies. The Hon’ble Tribunal has directed as follows:

“We, therefore, direct all the Regulatory Commissions to file their respective affidavit within two weeks from today furnishing details of (a) the Regulatory Assets with respect to each Discoms, within their jurisdiction, as on 01.04.2024; (b) the Revenue Gap (whether carried forward or not) as reflected in each ARR upto 01.04.2024; (c) the trajectory/ roadmap for liquidation of these Regulatory Assets/ ending the revenue gap upto 01.04.2024, so as to ensure that the entire Regulatory Assets/ Revenue Gap is liquidated latest by 31.03.2028; (d) the steps

taken by each of the Commissions to commence an intensive audit of the circumstances in which the Distribution Companies, operating within their jurisdiction, have continued to function without recovery of the Regulatory Assets/ Revenue Gap; and (e) the year upto which each of these Commissions have passed true up/ ARR orders with respect to each of the Distribution Companies within their jurisdiction.”

2. It is submitted that the present affidavit is being filed in pursuance of the said directions while furnishing details as requisitioned by the Hon'ble Tribunal.

In re: the Regulatory Assets with respect to each Discoms, within HERC's jurisdiction, as on 01.04.2024.

3. It is submitted that the HERC had issued a combined order in respect of the two DICOMs within its jurisdiction, i.e., Uttar Haryana Bijli Vitran Nigam Limited (UHBVNL) and Dakshin Haryana Bijli Vitran Nigam Limited (DHBVNL), for true-up upto Financial Year (“FY”) 2023-24, i.e., up to 31.03.2024. The HERC has not approved any Regulatory Asset in respect of the DISCOMs. Rather, there was revenue surplus for the FY 2023-24, amounting to Rs. 369.13 crore, which was carried over.

In re: the Revenue Gap (whether carried forward or not) as reflected in each ARR upto 01.04.2024.

4. It is submitted that no revenue gap was approved during true-up exercise for the FY 2023-24.

In re: the trajectory/ roadmap for liquidation of these Regulatory Assets/ ending the revenue gap upto 01.04.2024, so as to ensure that the entire Regulatory Assets/ Revenue Gap is liquidated latest by 31.03.2028:

5. It is submitted that since HERC does not have any Regulatory Assets, hence such trajectory/roadmap is not applicable in the present case.

In re: the steps taken by HERC to commence an intensive audit of the circumstances in which the Distribution Companies, operating within their jurisdiction, have continued to function without recovery of the Regulatory Assets/ Revenue Gap:

7. HERC has issued combined order in respect of Uttar Haryana Bijli Vitran Nigam Limited (UHBVNL) and Dakshin Haryana Bijli Vitran Nigam Limited (DHBVNL), i.e., DISCOMs within its jurisdiction, for true-up up to the FY 2023-24 and ARR for the FY 2025-26.
