Subject:- Engagement of staff in the Haryana Power Utilities through outsourcing.

Sir,

I have been directed to enclose herewith a copy of a news item appearing in The Dainik Tribune dated 11.12.2015 for your kind perusal. The news states that a contractor (M/s M.S Priya Electronic) engaged for supply of manpower on outsource basis in Faridabad circle has runaway after collecting Rs. 13 Lakh as advance payment from the Department. The Commission has taken a serious note of the matter. Such incidents have also happened in the past.

The Commission is of the view that in such matters, the State Government/Haryana Power Utilities should evolve policies in such a manner that no advance payments are made and in case these are to be made then there should be enough coverage in the shape of appropriate Security / Bank Guarantee.

The Commission is also of the view that only the technical staff essentially required for operation and maintenance of the system be outsourced whereas for other jobs the pass out students of ITI / Diploma courses may be engaged as already advised to the companies vide this office Memo No. 1609-1611/HERC/Tech. dated 08.09.2015 (copy enclosed), so that such type of losses are minimized.

I have, therefore, been directed to request you to take necessary action accordingly.

बिजली निगम के 13 लाख लेकर कंपनी फरार

फरीदाबाद, 10 दिसंबर (हप्र)

बिजली निगम में अनुबंध पर कर्मचारी उपलब्ध कराने वाली एक कंपनी बिजली निगम को ही चूना लगा गयी। कंपनी कर्मचारी उपलब्ध कराने के लिए जारी टेंडर के बाद एडवांस में 13 लाख रुपये लेकर फरार हो गयी। बिजली निगम के एक एनआईटी जोन के अधिशासी अभियंता की शिकायत पर मुजेससर थाना की पुलिस ने मामला दर्ज कर लिया है।

कुछ महीने पहले बिजली निगम ने अनुबंध पर कर्मचारी उपलब्ध कराने के लिए टेंडर जारी किया था। टेंडर जारी होने के बाद हिसार स्थित एमएस प्रिया इलेक्ट्रॉनिक नाम की कंपनी ने टेंडर भरा और इसके बदले कंपनी से बिजली निगम से एडवांस में 13 लाख रुपये लिए। पुलिस ने शिकायत मिलने के बाद आरोपी कंपनी के खिलाफ विभिन्न धाराओं में मामला दर्ज कर लिया है।
